Smoke Alarms & Safety Switch

Property owners must ensure their rental property is fitted with the required number of working alarms complying with Australian Standard 3786 and installed in accordance with the Building Code of Australia (BCA), Building Regulation 2006 Qld and Building Fire Safety Regulation 2008 Qld.

Additionally, the Queensland Fire and Emergency Services Act 1990 requires that property owners must test and clean each smoke alarm **within 30 days before each new tenancy**, including tenancy renewals.

Property owners must also replace each battery that is flat or almost flat and must replace smoke alarms before they reach the end of their service life.

Safety Switches - from 1 March 2008 property owners of leased domestic residences must also have a safety switch installed for the power circuit of the residence after a residential tenancy agreement has been entered into (this also applies to periodic tenancies which are not updated).

There is no legal requirement placed upon landlords to test the safety switch before or during a tenancy. Safety Switch trip test and report service available for only \$10.00* (non-mandatory).

From as little as \$59.00 we can attend your property to assess for both smoke alarm and safety switch compliance and complete the required smoke alarm maintenance including the replacement of batteries where required for compliance and issue a detailed compliance report.

New Smoke Alarm Regulations

Although strongly recommended, there is no requirement for property owners to upgrade their properties to the new Queensland smoke alarm regulations yet, however the deadline is now fast approaching.

From 1 Jan 2017 a ten year lead in period applies to have properties upgraded (by 1 Jan 2027).

At the first point of sale or lease at a property **on or after 1 Jan 2022**, the property must meet with the new regulations.

If at any time a property is subject to a building application on or after 1 Jan 2017, a building certifier will prescribe the required upgrades.

We urge property owners to **ACT NOW** and avoid the last minute rush, price rises and expected shortage of tradespersons available.
